#### **Notable Cases/Matters**

- Live Scape Sdn Bhd v World Wonder Fest Sdn Bhd [2023] MLJU 96 acted as lead counsel for a prominent live arts/event management company in a protracted dispute pertaining to a large scale K-PoP event, being victorious on all fronts -7 figure compensatory damages, damages for defamation, including costs for the entire action. Also causing for the dismissal of the opponents counterclaim as a whole.
- Minister of Finance (Incorporated) & 1 Malaysia Development Berhad (1MDB) v International Petroleum Investment Company & Aabar Investments PJS [2021] EWHC 2949, acted as lead/coordinating solicitor in Malavsia representing 1MDB and Ministry of Finance Inc (MoF Inc) in their multi-billion dollar claim/ arbitration. The High Court of England and Wales had recently granted the statutory extension of time to 1MDB and MoF Inc for the purposes of challenging a 2017 Consent Award with International Petroleum Investment Corporation and Aabar Investments PJS.
- CapAsia Solar One Ltd v Sun Energy Ventures Holdings (Labuan) Ltd & Ors [2021] 12 MLJ 296, represented Sun Energy Ventures group of companies in a USD 25,600,247.00 (approximately RM107,521,457.40) dispute pertaining to (amongst others) a photovoltaic solar energy power project spanning across West and East Malaysia, which involved nuanced issues of legality between offshore instruments pertaining to debt/equity financing, mezzanine finance, foreign bank licensing, the Labuan Financial Services Act (LFSA), capital markets law, the contractual binding effect of a pre-agreed exit strategy in an investment. Ultimately caused for the materialisation of a full and final settlement against all Defendants represented with absolutely no liability attached.



- ADM Ventures (M) Sdn. Bhd. & Ors v Renew Capital Sdn Bhd & Ors and other cases [2021] MLJU 1466, acted as lead counsel and successfully defended City Motorsports Sdn. Bhd., its director and shareholder respectively in a protracted multi-party (12 consolidated suits) minority oppression shareholder dispute pertaining to the KL City Grand Prix street race, a V8 Supercars international racing series. The litigation lasted over a period of 5 years.
- Fullbright Vista Sdn. Bhd. v Sabakekal Sdn Bhd and Sabah Development Bank Berhad, acted as chief/instructing solicitor for Fullbright Vista (FBV) and successfully obtained a Consent Order to preserve FBV's contractual and commercial rights under a Collaboration Agreement and the Renewable Energy Power Purchase Agreement, averting a catastrophic insolvency.
